7. Public Hearings, Briefings and Action Items:

A. Mayor Jones opened a public hearing at 7:19pm to receive citizen comments and input on Ordinance 482 reenacting the curfew.

Following a briefing on the topic by Chief Reaves, there were no citizen comments. Mayor Jones closed the public hearing at 7:20pm.

B. Discuss and take action on Ordinance 482 reenacting the curfew ordinance. (In accordance with the Texas LGC 370.002, the existing ordinance must be reviewed and re-adopted every three years, it was last adopted in July of 2018. The CCPD Board recommended approval at their June 29th meeting.)

MOTION to adopt Ordinance 482 reenacting the curfew ordinance.

C. Review and discuss the proposed fiscal year 2021-2022 Budget.

Mayor Jones reported that the timing of Ms. Barrett's appointment did not allow for the thorough review of the budget before the meeting. The city is behind in the budget process but will be back up to speed by the August meeting. Ms. Barrett provided a general overview and thanked the council for their understanding.

D. Discuss and take action to authorize the mayor to execute an interlocal agreement with the city of Lake Worth for animal control services. (Town and Country Veterinary Clinic has notified the city they are terminating our animal services agreement, effective July 12th. Staff has secured temporary arrangements from the City of Lake Worth Animal Control and is working with them on an interlocal agreement for future services.)

DISCUSSION: Ms. Barrett provided a recap and answered council and audience questions.

MOTION to authorize the mayor to execute an interlocal agreement with the city of Lake Worth for animal control services.

E. Discuss and take action on Ordinance 461-I to extend the Declaration of Local Disaster and Public Health Emergency originally issued by Mayor Jones on March 7, 2020, and last extended by the council on April 13, 2021. (The city participates in the Tarrant County Hazard Mitigation Action and Emergency Management Plans and must also comply with the State and County orders during a disaster. The mayor/council can also declare a city disaster, the current city disaster declaration will expire at midnight on July 31st.)

DISCUSSION: Ms. Barrett provided a recap and answered council and audience questions.

MOTION to adopt Ordinance 461-I to extend the Declaration of Local Disaster and Public Health Emergency to expire on September 30, 2021, at midnight.

- F. Review and discuss the preliminary storm drainage model and potential results.
 Ms. Barrett reported that she and Public Works Director Cody Cooke-Morse had participated in several conversations with Kimley Horn. They anticipate a preliminary report within the next 30 days and a council report in September. She suggested the council consider a special meeting for review of this topic.
- G. Mayor Jones opened a public hearing at 7:39pm to receive citizen comments and input on rezoning and site plan submitted by Blue Sky for Lot 3R Block 2 of The Shoppes of Hawks Creek, commonly known as 6660 Hawks Creek Ave, Westworth Village, Tarrant County Texas, currently zoned as Commercial (C) to Planned Development (PD) for a multi-family senior apartment project. (The Council postponed April 11th public hearing to May 11th, the property owner requested postponements of the public hearing on May 11th and June 8th. The property owner has again requested this public hearing be postponed; therefore, it will again be opened and recessed to the August 10th Council meeting.)

Mayor Jones recessed the public hearing at 7:40pm to the August 10th council meeting.

H. On April 11th, the Council postponed action on an ordinance rezoning and site plan for Lot 3R Block 2 of The Shoppes of Hawks Creek, commonly known as 6660 Hawks Creek Ave, Westworth Village, Tarrant County Texas, currently zoned as Commercial (C) to Planned Development (PD) for a multi-family senior apartment project, to the May 11th meeting allowing additional time to complete the site plan review. (Since the public hearing is being recessed at the request of the property owner to the August 13th meeting, no action can be taken.)

No action was taken.

Mayor Jones did not call an Executive Session as scheduled on the agenda.

The meeting was adjourned at 7:40pm by Mayor Jones.
