G. Public Hearing

Mayor Jones opened a public hearing to receive citizen comments and input on the adoption of the Fiscal Year 2022- 2023 Budget. The proposed budget is based on no change to the ad valorem tax rate of \$0.475 per \$100 of valuation. (Council will take action when the public hearing is closed at the special council meeting on September 20th.) at 8:49 PM.

H. Public Hearing

Mayor Jones opened a public hearing to receive citizen comments and input on the adoption of the 2022 Tax Rate of \$.475 per \$100 of valuation with the proposal to increase total tax revenues from properties on the tax roll in the preceding tax year by \$289,778, of which \$39,310 is tax revenue raised from new properties added to the tax roll this year. Your individual taxes may increase or decrease at a greater or lesser rate, depending on the change in the taxable value of your property and the tax rate that is adopted. (Council will take action when the public hearing is closed at the special council meeting on September 20^{th} .)
