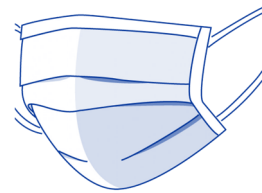

Face-Covering Requirement

In compliance with Tarrant County's Executive Order regarding Mandatory Face Masks, all persons over the age of 10 entering any City facility will be required to wear face coverings, including masks, scarves, bandanas, or handkerchiefs. As stated in the order, "patrons who do not wear a face-covering will be asked to leave the premises and will not be provided goods or services until the face-covering requirements are followed." In addition, we still ask individuals to maintain six feet of social distancing where possible.



Speed Limits

At the last Council meeting, Ordinance 465 was passed, reducing the speed limit on all city streets to 25 mile per hour, excluding alleyways, school zone on Burton Hill Road, Burton Hill Road, White Settlement Road East of Roaring Springs Road to the city limit, Roaring Springs Road, Pumphrey, and Highway 183/ Westworth Blvd city limit to city limits.

Throughout the upcoming weeks, the city will be placing signage on all applicable streets. Please be aware of this change and observe these new speed limits.

Water Quality Report

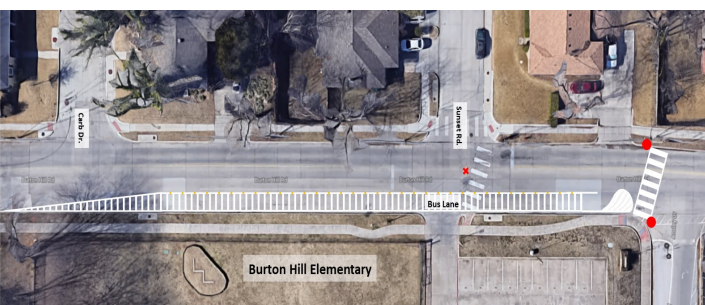

Burton Hill Crossing

The City will be updating the school crossing outside of Burton Hill Elementary by restriping the bus lane, removing the stoplight, and placing a button activated pedestrian crossing signal at Ansley Dr.

The City will continue to update the citizens as this change is underway, but please be aware of construction in this area.



Code Corner

Regarding outside storage, **Section 6.05.003 (b)** of the Westworth Village Code of Ordinances states that it shall be unlawful to accumulate any trash, rubbish, grass cuttings, dead trees, dead tree limbs, refrigerators or other appliances, carpets, accumulations of household goods, or any other debris on the property within view of any street or alley. Items shall be considered to be in view even if covered with a tarp or by other temporary means.

It is against City law to use your carport or patio for storage where it can be seen from the property next door, the street, or the alleyway ("in view").

The accumulation of unsightly materials and debris can have many negative consequences, including:

- Inviting criminal activity, such as vandalism and theft.
- Inviting rodents and pests. Rodents are always looking for food, nesting materials, or even a new home and can carry dangerous diseases.
- Lowering the overall aesthetic value of your neighborhood and creating a potentially dangerous environment for your fellow neighbors and citizens.

If you are currently in violation of this code, the City suggests some possible remedies to bring you into compliance:

- Donate items.
- Throw it away. Every Saturday is bulk pick-up day.
- Store it. You are allowed up to 2 storage sheds in the backyard.
- Contact your trash service (Waste Connections: 817-222-2221) for a special service. Note: There will be an additional charge from them to perform extra services.
