Hawks Creek Voted DFW Favorite

Friends and Fellow Citizens:

A year ago at this time, I presented a positive update on the financial turnaround and success of your city-owned and city-operated Hawks Creek Golf Club.

When I was honored to become your mayor six years ago, the golf course was losing approximately \$250,000 or more each year. Through the great work of our head PGA professional Bill Moorberg and our excellent course superintendent Kevin Lynsey, last year's positive turnaround has continued to even greater heights.

During the last fiscal year, your golf course showed an operational profit of \$562,000. During the current fiscal year, we are exceeding our budget projections, and estimate a current fiscal year operational profit of \$580,000.

Last year, I shared with you that your Hawks Creek Golf Club was named by the Fort Worth Star-Telegram as a "DFW Favorite" for the second year in a row. Once again, your golf course was chosen by the Star-Telegram's readers as a the second-ranked "Best Golf Course" in the Dallas -Fort Worth area for the third consecutive year!



After many delays, we are hoping for positive news on the long-awaited UnderPar Life project within the next 45-60 days. Additionally, there is another exciting financial opportunity for the golf course in the works, and we are hoping to share positive news with you on both fronts within the near future.

I ended last year's golf course message by saying "The future of Hawks Creek Golf Club looks brighter than it ever has!" **Today, I am happy to reiterate that same positive statement!**

As always, it's an honor serving as your mayor, and please let me know whenever I might be of assistance.

Extreme Heat

With the temperatures soaring, we remind citizens to exercise extreme caution when out in the heat and know the following signs and treatments for heat-related illness per **ready.gov**:

Heat Cramps

Signs: Muscle pains or spasms in the stomach, arms, or legs. **Actions:** Go to a cooler location. Remove excess clothing. Take sips of cool sports drinks with salt and sugar. Get medical help if cramps last more than an hour.

Heat Exhaustion

Signs: Heavy sweating, paleness, muscle cramps, tiredness, weakness, dizziness, headache, nausea or vomiting, and fainting.

Actions: Go to an air-conditioned place and lie down. Loosen or remove clothing. Take a cool bath. Take sips of cool sports drinks with salt and sugar. Get medical help if symptoms get worse or last more than an hour.

Heat Stroke

Signs: Extremely high body temperature (above 103 degrees) indicated by an oral thermometer; red, hot, and dry skin with no sweat; rapid, strong pulse; dizziness; confusion; and unconsciousness.

Actions: Call 9-1-1 or get the person to a hospital immediately. Cool down with whatever methods are available until medical help arrives.

Irrigation Restrictions

The city enforces a twice-a-week watering schedule. Water ONLY as needed and no more than twice a week per the schedule below:

- Mondays: No watering by any customer
- Tuesdays & Fridays: Commercial customers
- **Wednesdays & Saturdays**: Residential addresses ending in: 0, 2, 4, 6, 8
- Thursdays & Sundays: Residential addresses ending in: 1, 3, 5, 7, 9
- No watering between 10 AM 6 PM

OTHER:

- Drip irrigation, handheld or soaker hose watering allowed anytime.
- · No watering hard surfaces.
- No watering during precipitation.
- No water waste through runoff, or through missing, misaligned or broken sprinkler heads.

Code Corner

The following are common code violations experienced by the city. Those found in violation of these, or any, ordinances are subject to receiving a citation to appear in Court, as the city continuously enforces our ordinances.

Unsightly Storage

Storage of items on front porches, carports, and side yards could become dangerous and unsightly. Storing items such as: indoor furniture, appliances, construction material, household items, toys, scrap metal, automotive parts, tires, clothes, etc. visible to the public is a code violation as the accumulation of these items carports is an invitation to vandals looking for valuables, creates a habitat for vermin, and is unsightly for the neighbors. Covering outside storage piles or screening the front porch or carport with tarps or other material is not allowed.

Alleyway Maintenance

Property owners or occupants are responsible for maintenance of trees and shrubs which overhang alleys or plantings, shrubs and trees planted by the adjacent property owner in the parkway. (Per City Ordinance 6.05.003)

Citizens that have property adjoining the alleys must keep their portion of the alleys clear and ensure there is no overhang impeding vehicular traffic.

Street numbers are required to be displayed in a manner that is visible from the alleys, be a minimum of 3.5 inches in height, and in a color contrasting with the background (Per Fire Code and City Ordinance Sec. 5.04.002 Sec, 505.1)
