#### **ACTION ITEMS:**

**A.** Approval of both the minutes from the January 9, 2020 meeting minutes.

#### DISCUSSION

Councilwoman Mendez recommended an amendment to item B requesting that section be transcribed.

Motion passed vote of 5 Aves and 1 Navs (Mendez).

- **B.** Discuss and take action on the speeding concerns identified in the citywide survey and February 4<sup>th</sup> town hall meeting. (The City Council has requested the committee to consider reducing the speed limit on all streets to 25 mile per hour, excluding alleyways, school zone on Burton Hill Road, Burton Hill Road, White Settlement Road East of Roaring Springs Road to the city limit, Roaring Springs Road, Pumphrey, and Highway 183/Westworth Blvd city limit to city limit. This will cost approximately \$18,000 to purchase and install the required traffic signs and educational materials to inform the public.)
  - Chief Reaves presented a detailed review of the traffic studies and recommends approval.

MOTION to approve to reduce the speed limit on all residential streets to 25 mile per hour, excluding alleyways, school zone on Burton Hill Road, Burton Hill Road, White Settlement Road East of Roaring Springs Road to the city limit, Roaring Springs Road, Pumphrey, and Highway 183/Westworth Blvd city limit to city limit.




## **Staff Report**

**MAP KEY:** Residents were instructed to place green flags pointing at the locations where more lights were requested, and red flags were lights should be removed. This data was collected at the Town Hall meetings and in the city lobby for more than 6 weeks following the town hall meeting. The Red dots indicate existing public streetlights, green dots represent existing private streetlights and Yellow dots indication TxDOT streetlights.



#### **FINANCIAL:**

Per Dan Perfect at ONCOR in January, ONCOR will place a light on an existing pole at no additional charge. However, if a pole has to be erected at a designated location the cost per light will be approximately \$2000. The cost of 13 lights, provided new poles would be required in all locations, would be approximately \$26,000. Funding for the addition electricity cost has already been added to the proposed FY20-21 budget.

#### **OTHER FACTORS:**

- Exact placement at these locations may not be possible due to underground infrastructure; however, proximity could be achieved.
- Most of ONCORS existing poles are in the alleyways not along the street.

#### STAFF RECOMMENDATION:

At this meeting, request Chief Reaves review the identified locations, compare them with criminal activity, known public safety issues and recommend an order of implementation based on public safety. This would also allow him to identify existing poles in alleyways that could also be added in the interest of Public Safety.

At the September meeting, recommend council approve the installation of the streetlights in the locations and order of implementation identified by Chief Reaves.
