This account is funded by a ½ cent sales tax. The current sales tax is scheduled to expire on September 30, 2024 and must be placed on the ballot for a vote every 20 years. Expenses are restricted, but this account typically funds 5 FTEs police officer positions, police vehicle purchases, uniforms, community relations activities and various equipment maintenance contracts.
