CALLED TO ORDER at 5:32 pm by Chairperson Melva Campbell, noting the meeting started late due to a malfunctioning laptop.

The Chair opened Public Hearing #1 at 5:33pm to receive citizen comments regarding a zoning request to amend PD4 to allow 40-foot building heights and minimum 6:12 roof pitch on all lots in the Westworth Falls Subdivision, Westworth Village, Tarrant County, Texas.

- Sterling reviewed the application and provided a brief overview of the application, confirming that the required notices mailed.
- The following people spoke requesting that the Planning and Zoning Commission deny the request. Reasons cited varied, but included, decreased privacy, increased fire danger, damage to established trees and plants from blocked sun, increased flooding and run off, creation of a "high-density" housing area, decreased green space, failed to define specific reason or need for the extra 5-feet, and disrupts and detracts from the overall charm of the City:

The Chair opened Public Hearing #2 at 5:46pm to receive citizen comments regarding the zoning request to amend PD4 to allow a 5-foot first story and 20-foot second story rear setback on all lots and prohibiting second story rear windows on Block B, Lots 1-5, 7-18; Block C, Lots 1-2, 9-14; Block E, Lot 1 of the Westworth Falls Subdivision Westworth Village, Tarrant County, Texas.

 - Motion passed unanimously by a vote of 7 Ayes and 0 Nays.
- **B.** Discuss and take action on the zoning request to amend PD4 to allow 40-foot building heights and minimum 6:12 roof pitch on all lots in the Westworth Falls Subdivision, Westworth Village, Tarrant County, Texas.
 - Cheryl Chrisman requested the record to reflect that she has property within 200' of Westworth Falls, however she did not feel that this compromised her abilities to be participate in the discussion or vote.
 - Lee Nicol presented the project and explained the application, noting that he and the builders would like to have the ability to offer current styles, keeping with current building trends. His presentation provided examples of the roof pitch styles and photos of 2-story, 40-foot homes similar to the approved model home in Westworth Falls. He addressed the concerns that the citizens expressed in the public hearing, noting that the roof material was fire proof and the fire services provided by the Fort Worth Fire Department were exceptional. Regarding the reduced green space, Mr. Nicol explained that the architectural designs accounted for this and the space could be on the side, viewable by two rooms in the home.
 - Glenn Gibson, Victor Vasilio and Nancy Lamb again expressed their disapproval of the request.

MOTION to recommend City Council deny the zoning request to amend PD4 to allow 40-foot building heights and approve the request for a minimum 6:12 roof pitch on all lots in the Westworth Falls Subdivision, Westworth Village, Tarrant County, Texas.

- Motion passed by a vote of 6 Ayes and 1 Nays (Michael Lewis)
- C. Discuss and take action on the zoning request to amend PD4 to allow 5-foot first story and 20-foot second story rear setback on all lots and prohibiting rear second story windows on Block B, Lots 1-5, 7-18; Block C, Lots 1-2, 9-14; Block E, Lot 1 of the Westworth Falls Subdivision Westworth Village, Tarrant County, Texas.
 - Phillip Poole, Bob Shaw and Lee Nicol explained numerous building lay out options that could potentially alleviate the neighboring residents' concerns.

- Margaret Worthington questioned what would prevent them from have a balcony on the second floor, the request did not exclude doors on the second floor.
- Following a brief discussion with the Lee Nicol, he agreed to alter his application to include the exclusion of windows, patios, doors and balconies on the second floor.

MOTION to recommend council approve the zoning request to amend PD4 to allow 5-foot first story and 20-foot second story rear setback on all lots and prohibiting rear second story windows, patios, doors and balconies on Block B, Lots 1-5, 7-18; Block C, Lots 1-2, 9-14; Block E, Lot 1 of the Westworth Falls Subdivision Westworth Village, Tarrant County, Texas.

• Motion failed and the application was denied by a vote of 3 Ayes and 4 Nays. (Margaret Worthington, Cheryl Chrisman, John Hendrix and Darla Thornton)
