# 3. Staff Updates:

# A. Doug Reim, Police Chief

- Chief Reim recognized **Detective Darren Clark's 5<sup>th</sup> Anniversary with the Police Department**. Mayor Yeager stated his appreciation for Detective Clark's work and commitment to the City.
- Racial Profiling Report for FY 2012-2013: Chief Reim presented the annual profiling report.
- **PD Reports:** Priority Calls for Service 267, YTD 915; Self-Initiated Calls 989, YTD 2719; 911 Calls 200: Citations 144; Violations 231; Jail 52, YTD 165.
- Chief Reim made a presentation on Lt Lipperdt's participation in the Special Olympics Over the Edge fundraiser. Westworth Village raised over \$1000.
- Special Olympics Golf Tournament will be held on May 6th with shotgun start at 1:30pm.

# B. Ryan Studdard, Code Enforcement

- Code Enforcement Report: 23 code violations were addressed in December, YTD 603; No citations were issued in December, YTD 36.
- Inspection Report: 29 inspections were performed in December, YTD 636.

# C. Don Day, Senior Fire Chief

• Fire Dept Report: Total calls 45, including 15 EMS, 12 Fire calls, and 19 Mutual Aid calls to River Oaks; average response "in city" was 5.36 minutes. There were 40 training hours on Physical Training, Mutual Aid Apparatus Familiarization, and Fire Hose Deployment. Dept participated in Career Day at Burton Hill Elementary, Westworth Santa Parade, Hope for Hunter Benefit, and the Sansom Park Christmas Parade and Fireworks Demonstration.

## D. David Curwen, Director of Golf of the Hawks Creek Golf Club

- Director Curwen showed a video of the greens being covered due to inclement weather. It took 16 men 70 man-hours to spread the tarps. David thanked the Public Works team for their assistance throughout the storm. Weather caused the course to be closed 12 days in December; 19 days since the beginning of the fiscal year. That's more than the entire Fiscal 2013. Weather related damage to the grounds will be evident in the spring. Superintendent Sterling Naron expects there to be a 3-6 week lag in the normal growth season.
- Thanks again to the Public Works team for assistance with brush removal and maintenance.
- Golf Club Report: 1457 Rounds; \$65,665.97 Revenue. Senior play has declined.
- David is pursuing a marketing contract with **GolfNow**, a subsidiary of NBC Sports (including the Golf Channel). This opportunity will provide website and online tee time reservation, as well as point-of-sale (POS) programs, with the potential for significant cost savings over the current software.

#### E. Rhonda Hines, Librarian

- Library Report: Data upload and reports manipulation is going well. Material reservations by Consortium members are increasing. Library was only open 16 days in December due to inclement weather.
- River Oaks News reporter is writing a story on the library which will be published in two weeks.

• **Del Taco** manager Chris Blake offered bookmarks and food coupons to library patrons in the month of January.

# F. Roger Unger, City Administrator

- Capital Projects/Infrastructure: Coleman and Tracyne infrastructure projects are moving forward. Larry Briones and Laura Pinson confirmed the waterline along Coleman had been replaced in the 1990's by Carter Burgess, therefore eliminating that part of the project. Roger is very satisfied with the Fain Group construction team. Fort Worth is working on their waterline on Seymour. They will repave the street. Roger will meet with Freese & Nichols engineers to discuss the 2015 CDBG project. Tarrant County hasn't been as responsive as in the past regarding joint projects.
- Budget/Disbursements: Variance report shows CCPD expenditures higher due to two new vehicles purchased in 1Q14; Hawks Creek revenue is down due to weather; Court revenue is down due to a decrease in tickets written; sales tax revenue has increased; franchise fees have decreased.
- **FY 2012-2013 Audit:** Roger is pleased with the audit report. PB&H presented the audit to the Finance Committee earlier this evening.
- Public Works Service Order Report included in packet.

# G. Carol Borges, City Secretary

• Election May 10, 2014: Westworth Village will vote to elect Council Places 2, 3, and 4. Candidate filing period is January 29 through February 28. Application packets are available.

- A. Finance Committee –Kelly Jones, Chair The Finance Committee received the preliminary audit from PB&H earlier this evening. The City continues to be in splendid shape with 10 months of operating funds in reserve.

Chairman Jones expects further discussion before bringing a recommendation to Council. The Westworth Fire Dept continues to do a very good job for the residents.
