## **CITY COUNCIL APPROVES BUDGET FOR FISCAL YEAR 2013 - 2014**

The City Council adopted the FY2013-2014 budget on September 24<sup>th</sup>. The total budget for the City for next year is \$9,969,716. This includes \$1,672,000 for continuation of the street and all the infrastructure rehabilitation projects. The City experienced an increase in taxable valuation from \$165 million to \$175 million with over \$7.5 million coming from new construction within the City. The City tax rate of \$.492/\$100 of value will remain the same. The complete budget is available for viewing on the City's web site or in hard copy in the lobby of the Municipal building. We look forward to continued growth in both residential and commercial construction and anticipate another good fiscal year for 2013 and 2014.

## **CITY ALLEY WAYS**

City alleys serve a vital function to the homeowner and to the City. City vehicles, utility trucks, police cars and fire trucks must be able to travel in the alleys without being damaged by brush or tree limbs. Alley ways maintenance requirements can be found in Chapter 6 of the City Ordinances as follows:

**Sec 6.05.003 (a)(1)** It shall be unlawful for any person owning, leasing, claiming, occupying or having supervision or control of any real property, occupied or unoccupied, improved or unimproved, developed or undeveloped, within the corporate limits of the city, to suffer, permit or allow:

(E) Suffer or permit trees, shrubs, vines, bushes or other botanicals to grow beyond the vertical plane of the fence line of the alley adjacent to the premises, or over any portion of a public sidewalk less than seven feet (7') above such sidewalk.

(3) The City shall maintain the alleys within the City. Such maintenance shall not include maintenance of trees and shrubs which overhang alleys, streets or parkways or plantings, shrubs and trees planted by the adjacent property owner in the parkway, which remain the responsibility of the owner or occupant of the property.

The trees must be trimmed to 13 feet 6 inches from the ground. Grass and brush must be cut back to the fence line. Please, do not attempt to trim limbs near any power lines. Tree branches encroaching on power lines should be reported to TXU Electric at 1-800-242-9113.

On **November 1, 2013**, Code Enforcement will begin issuing notices to residents whose vegetation is not in compliance with the above requirements. The City of Westworth Village will continue to monitor the alley ways to ensure compliance with the City's Ordinances. These procedures are not meant to punish individual property owners, but to maintain the greater good of the community by gaining compliance with adopted codes and are "reactive" and "pro-active" in that inspections are done when the City receives a complaint from others, and if the City observes the violation prior to a complaint. These procedures seek to maintain the appearance of the City and the quality of life for everyone.

It is the desire of the City to gain voluntary compliance with city codes. In an effort to assist homeowners with voluntary compliance, the City has located a trimming company that is willing to trim the vegetation along the alley ways for \$100 per lot (payment will be made directly from the lot owner to the contractor).
