MAY 7, 2016 CITY GENERAL ELECTION

MANAGING POLLUTED WATER RUNOFF

Households can prevent polluted runoff by picking up after pets and using, storing, and disposing of chemicals properly. Check your cars for leaks and recycle your motor oil and antifreeze when these fluids are changed. Also, please minimize car wash detergents, grime, etc. by using car wash facilities that do not generate runoff. RECYCLED CHRISTMAS TREES

GREASE DISPOSAL

Fats, oils and grease from cooking turkeys, chickens and other meats will congeal and block your pipes, causing sewer backup and garbage disposal problems. Prevent future problems and help the environment by pouring grease into containers. Use cat litter to soak it up, or let it solidify on the countertop or in your refrigerator. Then you can put it in the garbage. **Do not** pour grease in your yard. When it rains, grease will run off into the storm drains and pollute the environment.

PLEASE MONITOR YOUR DOGS

Thank you to all citizens for demonstrating pride for our City this past year. Code Enforcement looks forward to working with you in 2016. Residents are required to pick up what their pets leave behind on City streets and yards.

Code of Ordinances Section 2.01.010 Removal of dog feces

- (a) An owner, harborer, or other person having care, custody, or control of a dog commits an offense if he knowingly permits or by insufficient control allows the dog to defecate in the city:
 - (1) On private property other than property owned, leased, or controlled by the owner, harborer, or person having care, custody, or control of the dog; or
 - (2) On public property or any other place to which the public or a substantial group of the public has access, including, but not limited to, a street, sidewalk, alley, park, or play ground, or any common area of a school, hospital, apartment house, office building, transport facility, or shop.
- (b) It is a defense to prosecution under subsection (a) that:
 - (1) The owner, harborer, or other person having care, custody, or control of the dog immediately and in a sanitary manner removed and disposed of, or caused the removal and disposal of, all feces deposited on the property by the dog;
 - (2) The dog was specially trained to assist a person with a disability and was in the care, custody, or control of that disabled person at the time it defecated on the property;
 - (3) The owner or person in control of the property had given prior consent for the dog to defecate on the property; or
 - (4) The dog was being used in official law enforcement activities.
- (c) Any person other than a disabled person who has a dog on a leash shall have on his or her person a plastic bag for the purpose of picking up such dog's feces. Such bag shall be presented upon request by any city officer or employee.
- (d) A person who violates this section is guilty of an offense and upon conviction is punishable by a fine not to exceed \$50.
